## WELCOME!

Since our July newsletter we have had so many new members join us! Absolutely fantastic to have all those applications, thank you. Please keep them coming we still have room for more.

One point most commonly raised is that in this very technical age it does seem antiquated to request payment by cheque. We often hear "I don't have a cheque book!" or "why don't you let us pay online" Online payment is reliant on correct information being provided at the time of the booking, believe me this can be a problem but we really need the physical application to set up the event. Online payment is impracticable when organising attendees for multiple events and refunding if an event is cancelled would be a logistical issue too. Whilst cheques seem outdated they can be destroyed if a cancellation takes place, refunding maybe 100+ people who have paid online would be a huge time consuming task for our committee members.

Are you aware you can order a cheque book through your online banking or by speaking to your bank direct? When using a card reader to sign into Online banking with Barclays Bank for instance under "Manage Accounts" > "Order" > "Order Cheque Book" you can get a new cheque book in a week. I have just ordered one it came in less than a week. We hope to see you soon at an event of your choice.

### Important information regarding joining the Club re our application form

The Retirement Club is funded by The Bank. The Club can only apply for funding per member and per member attendance at any event for those members in category 1-3.

All applicants need to be aged 50 and over. A Barclays Pension is part of the Barclays Bank Retirement Fund (UKRF).

**"Pensioner (Full) Member": Categories 1-3: You need to be in receipt of Barclays Pension, OR your pension is deferred and you worked for the Bank for at least 15yrs OR you are the widow or widower of a pension member and in receipt of a partners UKRF pension.**

**"Associate Member" You have transferred your pension out OR a partner to a member OR didn't complete the qualifying length of service, you can apply under category 4-5.**

Barclays Bank do not fund the Club for these members. For these reasons we have introduced a two tier charging for events.
